- C. <u>SUSTAINING MEMBER</u>: Any person or entity interested in the objectives and purposes of this Association upon written application and approval by the Board of Directors may become a sustaining member upon the acceptance of payment of annual dues to be set by the Board of Directors. Sustaining members shall have all the privileges of this association except that they shall not have the right to vote or hold elected or appointed offices.
