## American Bar Association Paralegal Definition Change

At the February 2020 ABA midyear meeting, the American Bar adopted Association resolution to change its official definition of paralegal, recommended by the Standing Committee on Paralegals. The resolution removed the term "legal assistant" from the ABA's of definition paralegal, replacing the previous definition adopted in 1997.

#### **Weird Laws**

#### **Coin Flips**

In Richmond, Virginia, it is illegal to flip a coin to decide who pays for coffee.

In the past, many decisions have been made on a coin flip. Orville and Wilbur Wright, the brothers who invented the airplane, decided who would perform the first test flight with a coin toss. Two New England natives tossed a coin to decide the name of Portland, Oregon when it was settled. The last seat on Buddy Holly's plane in 1959 was decided on a coin and ultimately sealed the fate of the winner, Ritchie Valens, who died in the subsequent crash.

Gambling has been a point of debate in the state of

Virginia. Title 18.2-325 of the Code of Virginia defines this as "making, placing, or receipt of any bet or wager [...] in exchange for a chance to win a price, stake, or other consideration or thing of value, dependent upon the result of any game, contest, or any other event". Those who engage in the type of gambling as described in this code could face charges of a Class 3 misdemeanor.

Contradicting this law is Title 24.2-674, also known as "Determination by lot in case of tie". During elections concerning public officials, such as mayor of a city or a seat in the House of Delegates, if two or more persons involved in the election are tied, then the tie should be broken simply by luck: drawing straws, picking a name from a hat, dealing a card, or flipping a coin.

It could be that flipping a coin in Richmond is interpreted as gambling. Laws are easily interpreted differently from person to person, city to city. But it is hard to overlook that flipping a coin has been prevalent in decision making for centuries. Maybe a coin toss to decide who pays for coffee is simply just a fun way to settle a disagreement with a friend.
